Executive Summary

As outlined in Tenn. Code Ann. § 33-11-105(b) the Council shall create and the Director shall deliver to the Governor, the Speaker of the Senate, the Speaker of the House of Representatives, the Chairs of the Government Operations Committees of the Senate and House of Representatives, and the Chairs of the Finance, Ways, and Means Committees of the Senate and House of Representatives on or before September 30 of each year an annual report for the prior fiscal year that details the following:

- Total funds deposited into the opioid abatement fund,
- The abatement strategies funded, and
- Any disbursement or expenses paid from the opioid abatement fund.

Highlighted FY2023 (July 1, 2022 - June 30, 2023) Key Activities

- Executive Director, Mary Shelton, began employment on September 6, 2022
- Opioid Abatement Council Staff were appointed: Project Administrator, Ella Reding, and Program Manager, Elizabeth Rickman-Vaden, began employment on December 5, 2022, and January 6, 2023, respectfully
- The Opioid Abatement Council met 8 times via 3 virtual and 5 in-person meetings
- First Annual Payments totaling \$31.4 million were paid out to all 95 Counties in February and March
- Began planning and design for the Community Grant application, which is expected to open on September 1, 2023

The Focus of this Annual Report

This report covers only those funds disbursed to the opioid abatement trust fund which is managed by the Opioid Abatement Council. The trust fund, formally named the Tennessee Opioid Abatement Fund Trust, was established by statute in 2021. The trust agreement was adopted by the Opioid Abatement Fund Trust Board of Trustees on April 13, 2022.

Gratitude for the Attorney General's Office

The Opioid Abatement Council would like to acknowledge the years of work by staff of Tennessee Attorney General's Office as they negotiated the multiple settlements which are paying dollars now available to prevent and address the misuse and abuse of opioid products and treat or mitigate opioid use or related disorders or other effects of the opioid epidemic. They continue to lead future negotiations and offer valuable guidance to the Executive Director and the Opioid Abatement Council.

Council Overview

Tennessee's Opioid Abatement Council was created by the Tennessee General Assembly in Public Charter 491 to manage the disbursement of proceeds from lawsuits relating to opioids. The Opioid Abatement Council upholds the responsibility to ensure the disbursements of these funds go toward funding programs, strategies, expenditures, and other actions designed to prevent and address the misuse and abuse of opioid products and treat or mitigate opioid use or related disorders or other effects of the opioid epidemic. The Department of Mental Health and Substance Abuse Services (TDMHSAS) staffs the Council and provides administrative support.

Law related to the Opioid Abatement Council is found at T.C.A. §§ 33-11-101 et seq. Law related to the Opioid Abatement Trust Fund is found at T.C.A. §§ 9-4-1301 et seq.

Council Members

As established by the Tennessee General Assembly in statute, the Council is to have 15 voting members who are appointed by the Governor, the Lieutenant Governor, the House Speaker, the Tennessee County Services Association, and the Tennessee Municipal League. TDMHSAS Commissioner Marie Williams serves as a nonvoting member.

The Opioid Abatement Council's current staff members include Mary Shelton, Executive Director; Ella Reding, Project Administrator; and Elizabeth Rickman-Vaden, Program Manager.

Council Responsibilities

The Opioid Abatement Council upholds the responsibility to ensure the disbursements of these funds go toward funding programs, strategies, expenditures, and other actions designed to prevent and address the misuse and abuse of opioid products and treat or mitigate opioid use or related disorders or other effects of the opioid epidemic. Disbursement directives include:

- Funding or supporting opioid abatement and remediation purposes and related administrative costs
- Creating a list of approved programs for opioid abatement and remediation for use by the council, state, or local government
- Creating a certification process through which government entities verify the use of funds for programs on the council's list of approved programs

- Incorporating input from the TDMHSAS Statewide Planning and Policy Council's Need Assessment Process
- Developing policies for stakeholder input
- Reporting annually on funds deposited, strategies funded, and disbursements of the funds

Council Meetings

The Opioid Abatement Council is required by statute to meet at least quarterly and move the meetings between the three grand regions of Tennessee.

In FY2023, the Council met 8 times, calling 3 virtual emergency meetings which were necessary to plan for and vote to approve new positions, policy statement and next steps to disburse the funds to the counties and to prepare to disburse the funds to the community.

The Council meetings are held in compliance with the open meeting requirements of title 8, chapter 44 of Tenn. Code Annotated. The meetings are held in-person with a virtual option for attendees to view and listen to the meeting. On average, there are about 40 guests at each meeting (including virtual and in-person).

The Opioid Abatement Council hears a brief reflection from the Council Chair at the start of each meeting on "Our Why", which grounds us and reminds us of our mission.

At the end of each meeting, the Council Chair asks those present either in-person or virtually if there is anyone who wishes to make a public comment.

Council Vision

"To approve and allocate the dollars through the Opioid Trust Fund so that Tennesseans struggling with opioid addiction with or without chronic pain find relief and pathways of recovery to bring hope and restoration through effective and transparent work for all Tennesseans, which will bring prevention and support for those families impacted by opioid use disorder."



Opioid Abatement Trust Fund

The settlement agreements all devote the largest share of money to a fund restricted to future abatement. In Tennessee, payments are placed in the Tennessee Opioid Abatement Fund. This is a trust fund, separate from the State's General Fund, and money in the fund must be spent of future opioid abatement and remediation.

Disbursement of Funds based on Public Charter

The Opioid Abatement Council is entrusted to manage 70% of the funds received from settlements and bankruptcies. These funds are deposited in the Opioid Abatement Trust Fund.

35% will go to all 95 counties based on a calculation agreed on by the Attorney General's Office and all counties. All 95 counties will receive at least one annual payment during Quarter 1 of each calendar year.

County Annual Payments

The counties receive 35% of the Opioid Abatement Trust Fund. Here is an overview of our activities which expeditated the first annual payments to all 95 counties totaling \$31.4 million in February and March of 2023.



County Letter of Agreement

A Letter of Agreement (LOA) is a document between the Opioid Abatement Council and each county, stating the guidelines for the Opioid Abatement Funds. Each county is required to execute the LOA prior to disbursement of funds.

- The Letters of Agreement (LOA) are sent via Adobe sign.
 - Disbursed funds must be spent on opioid abatement and remediation purposes.
- All records shall be maintained in accordance with state law.
- The county shall obligate all funds for specific purposes as consistent with the agreement within the initial two-year time period of the four-year time period.
- By statute, counties must report semi-annually on the use of funds received through disbursements from the Opioid Abatement Trust Fund.
- For this report, the Council will be using Formstack as their report platform.

Tennessee Department of Mental Health and Substance Abuse Services (TDMHSAS) attorney assigned to the Opioid Abatement Council Office, will annually review, and approve the Letter of Agreement.

The Opioid Abatement Council has set out the high-level requirements for the semi-annual reports in the Letters of Agreement with each county, which include identifying the types of abatement and remediation strategies funded and number of people served. The current copy of the Letter of Agreement can be found in *Attachment A (page 19)*.

County Semi-Annual Report

The platform, Formstack, is used to collect data of how the counties are utilizing the fundings. Reports showing how the Opioid Abatement Trust Funds were allocated and/or spent are due from each county by September 30 and March 31 of each year.



Community Grants

The community receives 65% of the Opioid Abatement Trust Fund. Here is an overview of our activities which began in Winter 2022 and continued through Summer 2023. We anticipate this will allow for a September 1, 2023, opening of the Community Grant applications.



Funding Information

Project duration is flexible based on Proposer's demonstrated need, timing of the program. The Opioid Abatement Council has not set a maximum funding amount for each approve application, though amount will be based on guidance set by the Council. Grant contracts awarded must comply

Timing of the funding is flexible and based on OAC approval for either 1, 2, or 3 years.

with all applicable contract requirements and the Proposer's application and will be subject to both programmatic and fiscal monitoring. The Opioid Abatement Council Community Grants will be funded on a quarterly basis and the funds are not considered federal or state. Grantees will submit semiannual reports to the Opioid Abatement Council Office and will also be subjected to fiscal and program monitoring, which will be performed by TDMHSAS and/or the Opioid Abatement Council Office.


Grant Application Platform

SmartSimple

The Opioid Abatement Council is working with Strategic Technology Solutions (STS) located within the Department of Finance and Administration, to customize the state-owned platform for the grant application portal. Since this platform is owned by the State of Tennessee, no Opioid Abatement Trust Funds are spent on this project.

Community Grant Application Portal

The Community Grant applications will be submitted through the Sub-Recipient Grant Management Enterprise Solution, State of Tennessee Portal. The Community Grant application can be found in *Attachment C (page 25)*.



We would like to highlight our positive experience with the SmartSimple platform and the Sub-Recipient Grant Management Enterprise Solution.

The STS staff are helpful and responsive to our needs and we expect a timely go-live.

Criteria for a Qualified Grant Application

The eligible projects are listed on <u>Tennessee's Opioid Abatement & Remediation Uses</u>. The Proposer must be located in Tennessee and request funding for the projects listed on the Tennessee's Opioid Abatement & Remediation Uses.

Grantees are selected based on how the project's impact, innovation, integration, evidence base, feasibility, sustainability, and credibility within the systems which work towards opioid abatement and remediation.

Opioid Abatement Council

Proposal Scoring and Selection

Proposals are scored based on the ability to demonstrate the intended success of the project. Based upon the evaluations, proposal selections will be made and submitted for final approval to the Opioid Abatement Council. Grantees will be notified of their approval via email of next steps.

Town Halls

The Opioid Abatement Council hosted three Town Hall meetings at the end of July 2023 in Murfreesboro, Cleveland, and Dyersburg with about 110 people attending total.

On May 24, 2021, the Tennessee General Assembly passed Public Chapter No. 491 establishing the Opioid Abatement Fund and the Opioid Abatement Council.

The Opioid Abatement Fund is the designated repository of funds that are either dedicated to opioid abatement or remediation or are otherwise directed to abatement or remediation and that are received by the state pursuant to a judgment on opioid-related claims, a recovery in bankruptcy on opioid-related claims, or a settlement of opioid-related claims. *See* Tenn. Code Ann. § 9-4-1304.

The Opioid Abatement Council is responsible for disbursing funds from the Opioid Abatement Fund. Pursuant to Tenn. Code Ann. § 33-11-103(p), for proceeds from the statewide opioid settlement agreements with McKesson Corporation, Cardinal Health, Inc., AmerisourceBergen Corporation, or Johnson & Johnson or affiliates or subsidiaries, thirty-five percent (35%) of the proceeds received shall be disbursed to counties that joined those settlements.

- b) Your county agrees to report on a semi-annual basis to the Opioid Abatement Council requested information. This request information may include, but not be limited to, the following:
 - (1) what abatement and remediation strategies on Attachment A your county with these funds,
 - (2) the number of people served with these funds, when the funds were spent, and
 - (3) the total amount of funds spent delineated per abatement and remediation strategy as identified on Attachment A.

More information on how to report this information will be sent to your county at a later date.

- c) If your county fails to fulfill the obligations under this agreement, the State shall have the right to seek restitution, pursuant to the laws of the State of Tennessee, against your county for payments made to your county under this agreement.
- d) Your county's records and documents, insofar as they relate to the performance of your county's obligations or to payments received under this agreement, shall be maintained in a manner consistent with the accounting procedures of the Comptroller of the Treasury, pursuant to Tenn. Code Ann. § 4-3-304 and applicable rules and regulations thereunder.
- e) The funds received shall be placed in an interest-bearing account until such time as they are used for the purposes set out in this agreement. The funds received shall be distributed to the county for an initial total time period of four years. The county shall obligate all funds for specific purposes as consistent with this agreement within the initial two-year time period of the four-year time period. At any time during the four-year time period, the county may spend the funds. At the expiration of the four-year time period, the unspent funds shall revert back to the State's Opioid Abatement Fund, unless the county requests in writing and receives approval from the Council for additional time. At the expiration of the four-year time period or at the end of any extension granted by the Council, if any portion of the funds are not expended, the unexpended portion plus any accrued interest shall be returned to the State's Opioid Abatement Fund. At the expiration of the four-year time period or at the end of the extension granted by the Council, if any portion of the funds are obligated but unspent and the Council has not approved an extension, the county shall be responsible for the obligation.

We encourage you to return these materials as soon as possible. The State is prepared to process this agreement and issue payment in a timely fashion, upon receipt of these materials.
